MISURA UNICA ABITARE - RENT SUBSIDY

From January the 25, 2021 it will be possible to apply for the regional subsidy "Misura Unica" in support of rent payment, intended for families facing difficulties as a consequence of Coronavirus emergency.

• Who can benefit:

The subsidy is intended for citizens having **at least one year of residence before the date 23 december 2020** in the municipalities of the the South-East Milan Social District, and it will be allocated to :

1- Families in limited no-fault arrears, meaning families that did not manage to pay the rent because of job loss or because of other occurrences linked to COVID -19 health emergency;

2- Families not in arrears that are facing difficulties in maintaining the house rent due to the occurrence of economical difficulties linked to the crisis of COVID– 9 health emergency.

THE CITIZENS THAT BENEFITED FROM MAY 2020 MISURA UNICA SUBSIDY ARE ALLOWED TO APPLY.

The economical difficulties of the family shall have arisen after the 31 January 2020.

• How the subsidy will be issued:

A subsidy will be issued to the owner of the house

- For applications of type 1 (Families in limited no-fault arrears) amountig to 4 monthly rents and in any case not exceeding € 1,500.00 for each house/contract;
- For applications of type 2 (Families not in arrears) amounting to 2 monthly rents and in any case not exceeding € 1,000.00.

• How to submit the application

Applications must be submitted exclusively through the dedicated platform that will be operating from 25 January 2021 at 12:00 until 26 February 2021 at 23:59 on the website <u>www.incrocicomuni.it</u>

• Documents to submit

- copy of the rent contract duly registered and valid;

- statement of the landlord showing the debt accrued by the tenant, net of the amount of the expenses (template available on the website <u>www.incrocicomuni.it</u>);

- valid identity document.

The applicants must state within the request that according to the requirements they hold an ISEE for year 2021 of maximum € 26,000.00. For families without ISEE 2021 certificate, ISEE 2020 will be considered valid too.
